What should a drilling contract include?

A drilling contract should address the standard of performance expected of the drilling contractor. The API drilling contract form requires the contractor perform "with due diligence and care, in a good workmanlike manner, and in accordance with good drilling practices."

How do drilling contracts work?

This information is generally provided through the Regional Geotechnical Section. However, there are occasions when additional assistance is necessary. At those times, drilling contracts are let to procure the services of companies experienced in obtaining subsurface information, soil and rock samples, for geotechnical engineering purposes.

What is an API drilling contract?

The API drilling contract form requires the contractor perform "with due diligence and care, in a good workmanlike manner, and in accordance with good drilling practices." The drilling contractor represents that it "is engaged in the business of drilling and completing ... wells ...."

What are the different types of drilling contracts?

The Independent Association of Drilling Contractors (IADC) has its own set of drilling contracts, and they are commonly used. Most of the wells in the United States are drilled under one of the three major types of drilling contracts: the Turnkey, the Daywork, or the Footage contracts. Examples of all three of these contracts are in the workbook.

How much does a rig operator pay a contractor?

Operator shall pay Contractor in addition to the operating rate specified above: (a) \$30 per man per day for Contractor's rig-site personnel. (b) \$N/A per day additional operating rate; and (c) Cost of all labor, material and services plus 24 hours operating rate to clean rig and related equipment.

How much does a drilling rig cost per day?

\$17,500 per day Using Operator's drill pipe \$ per day. The rate will begin when the drilling unit is rigged up at the drilling location, or positioned over the location during marine work, and ready to commence operations; and will cease when the rig and pits are cleaned & wellhead is installed.
